Investing in families and children's healthy development builds more resilient families, better educational outcomes and, in the long term, a stronger society.

#### Strong & Inclusive Workforce




We will work to strengthen the workforce that supports early learning, health and wellness by delivering services to North Carolina. And we will take action to be an equitable workplace that lives its values and ensure that all people have the opportunity to be fully included members of their communities.

The health insurance coverage gap coupled with insufficient access to affordable care disproportionately impacts Historically Marginalized Populations who have also experienced worse outcomes than others under COVID-19. Medicaid expansion would help close the health insurance coverage gap.

9-8-8 History	
2005	The National Suicide Prevention Lifeline launches with the number 1-800-8255
August 2019	FCC recommends use of 9-8-8 code for NSPL
July 2020	FCC designates the new number to connect people to mental health crisis services
October 2020	National Suicide Hotline Designation Act of 2020 is signed into law
November 2021	NFCC adopts rules to expand access to text 9-8-8 to directly reach the lifeline
July 16, 2022	Nationwide launch of 9-8-8!



- In 2020 the U.S. had one death by suicide about every 11 minutes
- The suicide rate is up 30% since 1999
- Suicide is a leading cause of death for people aged 10 – 34 years
- From April 2020 to 2021, over 100,000 individuals died from drug overdoses

  - Call/text: 9-8-8 or 1-800-273-TALK (8255)
  - Chat: Lifeline (988lifeline.org)
- Access to trained crisis counselors who can help people experiencing mental health-related distress. That could be:
  - Thoughts of suicide
  - Mental health or substance use crisis, or
  - Any other kind of emotion distress
- Free and confidential
- Crisis resources and referrals

## **REAL Crisis Intervention, Inc.**

- North Carolina's single NSPL call center
- Non-profit organization
- National Suicide Prevention Lifeline/9-8-8
  - Member of Lifeline Network NC and 1 of 9 National Backup Centers
- Call Volume since the launch of 9-8-8 on July 16, 2022
  - 7/2 7/15: 1,306 calls answered
  - 7/16 7/29: 2,235 calls answered

### 71% increase in calls!
